## 2020 Membership Rates

<b>Adult</b>	One adult, ages 26-64	\$53
<b>Family</b>	Two adults plus all dependents (up through age 25) who live in the same household*	\$93.50
<b>Single-Parent Family</b>	One adult plus all dependents (up through age 25) who live in the same household	\$69.75
<b>Senior</b>	One adult, ages 65 and older	\$45.75
<b>Senior Couple</b>	Two adults, ages 65 and older, who live in the same household*	\$66.50
<b>Couple</b>	Two adults, 19 and older, who live in the same household*	\$78
<b>Young Adult</b>	One adult, ages 19-25	\$30.75
<b>Teen</b>	One teen, ages 12-18	\$22
<b>Youth</b>	One youth, ages 0-11	\$17.75

**\*FAMILY PLUS.** If you have more than two adults living at home, the Attleboro Y offers Family Plus. Whether you have an adult child living at home, a parent living with you, a nanny, or any other adult residing in the household, you can add an additional adult to your Family, Couple, or Senior Couple Membership for only \$15 a month.

**JOIN FEE.** At the time of joining, there is a one-time fee of \$30 per membership, regardless of your membership type or membership rate.

**MONTHLY FEES.** At the time of joining, you will be charged a pro-rated membership fee based on the number of days remaining in the current month. After that, you will be charged your regular monthly fee on either the 1st or the 15th of the month (your choice) via automatic draft. You can choose for your membership fees to be drafted via a credit card or bank account.

Please note that if the fee is returned due to insufficient funds or inactive account, you will be charged a \$10 return fee, so please make sure you let us know if there is a change to your account before your next draft.

**PAYING ANNUALLY.** If you prefer, you may choose to pay your membership on an annual basis. Your rate is simply 12 times the monthly rate. We will send you a notification when your membership is up for renewal.

**MEMBERSHIP FOR ALL.** To ensure that our programs and services are accessible to everyone, the Attleboro Y offers the "Membership for All" program. This income-based membership rate scale welcomes all individuals and families to become active members of the Y, no matter what their financial circumstances may be. We are able to offer Membership for All because of donations made through our Annual Fundraising Campaign.

## MEMBERSHIP FOR ALL.

To determine your monthly membership rate, please review the chart below and find the percentage that corresponds with your annual household income and the total number of people in your household.

**This is the percentage rate that you will pay for your membership each month.** For example, if the standard Adult membership rate is \$53 and you qualify for a 42% membership rate, you will pay \$22.25 per month.

**VERIFICATION OF HOUSEHOLD INCOME AND SIZE.** To qualify for a Membership for All rate, you will need to provide the YMCA with tax documentation to verify your income **within 30 days of your membership start date**. These tax records should also demonstrate the number of dependents that you claim to verify your household size.

If you did not file taxes in 2019, you will need to fill out a 4506-T form, so that the IRS can verify this with the YMCA. You will also need to provide paystubs or benefits paperwork to verify your income rate.

**Please note:** If you do not provide the proper documentation within 30 days, the fee will default to the full rate.
